Hendrix Industries, Inc., a Texas corporation ("Hendrix") provides this Limited Lifetime Warranty to the owner of structure where Techno Quartz by Hendrix® product ("Product") was installed, subject to the terms and conditions of this Limited Warranty.

THIS LIMITED WARRANTY: (1) IS THE SOLE AND EXCLUSIVE WARRANTY EXTENDED TO PURCHASER AND IS IN LIEU OF ALL OTHER WARRANTIES (EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT), AND (2) REPLACES ANY AND ALL STATUTORY WARRANTIES (TO THE MAXIMUM EXTENT ALLOWED BY LAW). HENDRIX HEREBY DISCLAIMS ALL OTHER WARRANTIES. IN NO EVENT SHALL HENDRIX BE LIABLE UNDER ANY LEGAL THEORY FOR ANY DIRECT, INDIRECT, SPECIAL, EXEMPLARY, INCIDENTAL, PUNITIVE, CONSEQUENTIAL OR OTHER DAMAGES, INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION OR ANY OTHER LOSS, EVEN IF HENDRIX HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES (TO THE MAXIMUM EXTENT ALLOWED BY LAW). ### Who is covered by Warranty:

- Warranty is provided for the owner of the structure where the Product was originally installed.
- Warranty is nontransferable subject to the terms and conditions of this Warranty during the Warranty Period.
- Warranty Period is for Limited Lifetime starting on the Product's date of purchase.
- In order for Warranty to be effective, the Product must be registered within 30 days of installation at [www.hendrixindustries.com/warrantyregistration](http://www.hendrixindustries.com/warrantyregistration)

### What is covered by Warranty:

- Warranty is for installation of the Product at single family home, apartments, condominiums, hotels, motels, and other locations open to the general public.
- Hendrix warrants that the Product will be free from manufacturing defects for the intended use of the Product for the duration of the Warranty Period.
- Product must be maintained in accordance with Hendrix's Product Care and Maintenance Guide at [www.hendrixindustries.com/care&maintenanceguide](http://www.hendrixindustries.com/care&maintenanceguide)
- Manufacturing defects include material, visible or latent defects created by Hendrix, not by third parties.
- Upon confirmation of manufacturing defects, Hendrix will at its discretion provide a one-time repair, replacement or refund of Product to the warranty owner at the "Pro Rata" amount during the Warranty Period.
- Should Hendrix choose to replace the Product under warranty at the time of the replacement decision, it will do so only with inventory which it has on hand, which may vary in color intensity, hue or shade.
- Warranty does not cover any labor, shipping, secondary or incidental costs to remove or replace the Product.
- Warranty covers only polished finishes, not any other finishes including textured or honed finishes.

### Warranty Exclusions or Voidance:

- Warranty is not effective if Product was purchased via an unauthorized distributor or reseller. To confirm an authorized distributor, please visit [www.hendrixindustries.com/authorizeddistributor](http://www.hendrixindustries.com/authorizeddistributor)
- Warranty does not apply to Product which original finish or thickness has been altered.
- Warranty does not apply to Product that has been removed, replaced or altered after its original installation.
- Warranty does not apply to Product that has not been fully paid or has associated liens.
- Warranty does not apply to Product improperly fabricated or installed. Product must be properly fabricated and installed in accordance with Hendrix's guidelines at [www.hendrixindustries/fab&installationguide](http://www.hendrixindustries/fab&installationguide).



- Warranty does not apply to Product installed on inadequate support.
- Warranty does not apply to Product installed in violation of construction or building codes.
- Warranty does not apply to Product installed in abandoned or unoccupied building structures.
- Warranty does not apply to Product installed outdoors or directly exposed to sunlight or UV rays.
- Warranty does not apply to Product installed in areas exposed to saltwater.
- Warranty does not apply to Product installed for floors, sub-floors, high-traffic areas, shower trays, shower pans, steam showers, steam rooms or saunas.
- Warranty does not apply to Product installed on moving vehicles, including but not limited to cars, boats, RV's, planes, etc.
- Warranty does not cover damages resulting from unintended use of Product, including but not limited to creative use like bending or installation on entry-ways, ceilings, fireplaces, uneven walls or surfaces.
- Warranty does not cover scratches, chips, surface stains, or water spots.
- Warranty does not cover damages resulting from negligence or mishandling of Product, including but not limited to physical abuse, chemical exposure, high heat exposure, thermal shock, and outdoor exposure.

**WARNING:** Although our products themselves do not pose a risk to end consumers once installed, it is during manufacturing and fabrication that the tradesmen performing these tasks are at risk of being exposed to Respirable Crystalline Silica (RCS1) containing dust.
